I hereby waive and release any and all rights and claims for damages against the Shelter Island Heights Property Owners Corp., its officers, directors, employees, and members for any and all injuries or losses sustained in conjunction with the use of the Shelter Island Heights Beach Club facility and equipment. My guests and I will use the facility at our own risk. Membership is not transferable, and I agree to abide by all Heights rules and regulations.

Paid membership in the Heights Beach Club is subject to the rules and regulations that govern all members (see attached). Should the Heights rules, guidelines or standards of behavior not be observed, membership will be revoked and any unused membership fee will not be refunded on a prorated basis. I understand my membership and/or locker or cabana rental may be terminated at any time and contents removed if I do not abide by the Heights Beach Club rules and regulations. Security cameras installed will be checked as needed to maintain the integrity and safety of the members. If requested by the SI police Department or other law enforcement body, footage from the security cameras will be shared with the police or any like agency as part of a formal investigation. Photos of Heights Beach Club events and participants, may be used for the Heights Newsletter or other Heights promotional purposes.

- (1) Cabanas: in the event the Beach Club is rented for a private event, cabana renters agree not to use their cabanas or the Beach Club when notified by POC Staff of a private event. If I do not abide by this agreement, my rental term may be terminated, and no refund will be given.*
- (2) Non resident membership is limited to 4 guests per day, per household. Additional fees may apply for more than 4 guests per household, per day and/or termination of membership.*
- (3) Discounted Senior Membership is limited to the Senior and his/her Spouse (2 adults per household and limited to 4 guests per day, per household). Additional fees may apply for more than 4 guests per household, per day and/or termination of membership.*
